## EXAMPLE BY PERIOD

### Jaqueline generates in a Period:

500 S&W points which equal 1,000 Effective Points (500×2) and 2,000 from SS1

**Total Effective:** = 3,000 Points (1,000 + 2,000)

Multiplier: With 3,000 Points applies multiplier x8 = 24,000 Final Points

**Shares.** Every 50 points = 1 Share

24,000 Final Points ÷ 50 = 480 Shares

## Result:

**Jaqueline accumulated 480 Shares.**
