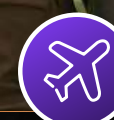

PCI SECURITY LEVEL 1

Your payment data is never stored at VIVRI. It is securely kept in the encrypted vault of IXOPAY.

- *This means that if there is a promotion or discount and you are in S&W meeting the promotion requirements, you automatically receive the benefit. For example, in a promotion "receive a free Shaker with a minimum purchase of \$100 USD," if you have an S&W of at least \$100 USD, you receive the Shaker.
- For the Cruise Certificate, a \$59.99 USD activation fee per certificate applies at the time of request.
- "Designated Purchases" keep the LIV active but do not participate in S&W benefits.
- The Car Leasing will be for 36 months, linked to the winner's chosen vehicle, with a retail price of up to \$100,000 USD or its equivalent in local currency. The drawing will be held live between May 21 and 27, recorded, and the result published during VIVRI CIEN. To promote meritocracy, the leasing winner will be determined by random selection with double confirmation and skill testing. VIVRI will process the leasing for the winner's benefit at the end of VIVRI CIEN. The leasing winner will have no additional point requirements; they only need to remain active as a LIV VIVRI and provide their car testimonial whenever requested by Corporate during the 36 months of use. In month 37, the car title and permanent ownership may be transferred to the LIV if desired, who will be responsible for paying the residual value. If a Client or Preferred Client wins, they must become LIV and remain active for 36 months.
- To provide a transition period, during July and August 2026, LIVs accumulating Select Access months to obtain their Cruise Certificate may continue under the current scheme. Starting September 2026, activating Save & Win (S&W) will be required to retain both the benefit and accumulated seniority.
